**Background:** The event is held within the initiative “Promoting transparency and implementation of anti-corruption measures in state-owned enterprises and local governments in Ukraine”, implemented by the International Centre for Policy Studies (ICPS), in partnership with the Institute for Economic and Social Reforms in Slovakia (INEKO). The initiative is financially supported by the Official Development Assistance of the Slovak Republic (SlovakAid).

The ranking «Financial Sustainability of State-Owned Enterprises in Ukraine» aims to improve the efficiency of the administration of state-owned enterprises. The financial indicators of top 50 Ukrainian state-owned companies were analyzed and an interactive portal to display the results for individual companies was created.
