# Independence of Key Public Institutions

Helping increase independence of key judiciary, control, regulatory and watchdog institutions

- Why independence?
  - Public institutions represent democratic tool in power division
  - Political interference and influence lower democracy and competitiveness
  - Autonomous institutions are protected from changing political environment
  - Politically independent institutions gain citizen trust and strengthen democracy

# Independence of Key Public Institutions

Helping increase independence of key judiciary, control, regulatory and watchdog institutions

- Why in Slovakia?

- Severe misuse of power since gaining independence in 1993
- Cool down period in 2000s as we enter EU and NATO
- Past decade serious suspicion of corruption in highest places
- 2020 – suspicions confirmed, with dozens of high ranking officers and judges currently under investigation and many under arrest

- **Evaluating independence of public institutions also helps us examine how easy it is for corrupt individuals to gain control over prominent public offices**





## APPOINTMENT AND POSITION OF THE GOVERNING BODY

What authorities appoint representatives, how many times can one person hold the office, how many people share the power within the institution

- Power division within institution (multiple members of governing body, control board)
- Two or more bodies must agree on a candidate for him to be appointed
- Limited office term (both how long and how many times)

BOTTOM 3		
24	Administration of State Material Reserves	36%
25	Financial Administration	27%
25	Agricultural Paying Agency	27%

- Ministers or government appoint representatives
- There is no division of power within the institutions
- Office term is unlimited

- Representatives can only be dismissed only in case of serious misconduct
- Decision to dismiss the representative must be made by multiple bodies

- Ministers or government decide to dismiss representatives
- No justification for the decision is necessary

- Institutions are legally guaranteed independence
- Government has no right nor means to interfere
- Decisions made by the institutions cannot be overruled by another body

- Government retains control over internal structure and affairs
- Institutions have no financial freedom
- NSA is essentially a subdivision of Ministry of interior

- Open competition to all qualified candidates
- Public hearing, streamed live
- Expert committee
- Results were presented to the public

**The processes allowed for public control**

- No official competition
- No criteria for candidates
- No public hearing

**All three candidates were chosen behind closed doors.**
